Phillip C. Huber, Chairperson, Presiding

Opening: Phil Huber called the meeting to order at 1:30 p.m. A quorum being present, Phil Huber opened with each person describing their highs and lows of the week.

Phil handed out a booklet called “Annual Meeting of the Board of Publications, Thursday, June 14, 2012, 1:00 to 5:00 p.m., Techny Towers, Techny, Illinois” (hereafter called “spiral”).

Roll call: Board members present were: Phillip Huber (Chair), David Dawson, Al Tizon, Mary Mott. Others present by reason of office were: Roger Schroeder (ASM President), Darrell Whiteman (Publisher), Richard Starcher (Editor of *Missiology*), David Fenrick (Book Review Editor of *Missiology*), Mike Rynkiewich (ASM Scholarly Monograph Series Committee), and Jay Moon (Secretary-Treasurer).

Visitors: Andi Greene (assistant for the *Missiology* journal).

Board members missing were: Howard Snyder, William Burrows, Judith Lingenfelter, Robert Hurteau, Lalsangkima Pachuau, Jon Bonk (ASM Series Committee).

Noting of the Minutes of June 16, 2011: The minutes of the meeting of June 16, 2011, having been approved by the Secretary-Treasurer and Chairperson, and distributed to the members in advance, were noted.

Approval of Agenda: The agenda was approved as presented.

Report of the Publisher: Darrell read his report on pp. 5-6.

Missiology Editor’s Report: Richard Starcher read his report on pp. 7-8. A discussion was held concerning the presentations at the pre-conference symposium. The BoP board will actively attend the symposium to find which ones have good potential for publication. Richard is considering e-publishing (as part of the January issue) the best four-six articles that are submitted following the presentations. The articles would need both content and quality review. Rich will explore this further.

Rich was concerned about the loss in subscriptions last year. Part of this is due to the way it was reported in previous years.

Scholarly Monograph Series Report: Mike Rynkiewich discussed his report. Discussion was held about promoting these books. It would help to have a link on the ASM website to direct people

to the Wipf & Stock website to purchase the books. James Krabill will take over as the chair of this committee.

ASM Series: Jon was not here to present this but Mike R. brought up an issue that has come to his attention. Some of the existing books in the ASM series are going out of print. Orbis is not interested in reprinting these. Mike asked if books could be printed by Wipf and Stock.

Report of the Electronic Media Committee: Genevieve Mougey and Patricia Fenrick are now on this committee. Most of the money spent this year has gone to the Content Management System (CMS). This is much more than just a website. This contains the database of the ASM members and it is used to register for the Annual Conference. This also keeps track of the Missiology journal registrations.

There was a one hour discussion on the proposal by SAGE for SAGE to publish the Missiology journal. Some of the advantages include:

1. They think they can increase the subscriptions since they bundle several journals together and sell them to libraries.
2. They will have a quality online journal

The following motion was moved, seconded, and approved: We will work by the end of Aug. to arrive at a decision on the SAGE proposal. The whole BoP will read the SAGE documents and then post comments in a Google doc that Phil will set up. A small task force will contact SAGE and investigate this proposal more thoroughly. The task group will be composed of: Rich Starcher, Darrell Whiteman, Jay Moon, and Nelson Jennings.

There are additional costs that Josh will need to fix on the website:

Presently, our fixed costs for the web site are: 35/mo (SSL certification?) + 75/mo (web hosting) + 200/mo (Dorothy). This is 420 + 900 + 2,400 + 2,000 for modifications of the website

This final amount will be requested by the ASM BOD of \$5,720.

Move, seconded and approved: Patricia Fenrick will be asked to be the next Electronic Media Committee chair person.

Report on New Online Journal: Phil will work on this and present it next year.

ASM Constitution, Bylaws, Article VI revised: George Hunsberger presented his work on the proposed bylaw changes in Section 4 on p. 21 (see red letters).

It was agreed that the process that we used to select the editor of the Missiology journal will also be used to select the editors, chairs and members for the ASM series, Scholarly monograph series, and electronic media committee. This also includes the Associate editors for the Missiology journal.

These efforts are intended to make this process very transparent.

Board of Pub Membership Changes:

David was thanked for his good service over the last three years. He will be moving off of the Board of Publications next year. Phil Huber informed the BoP that he will be coming off of the Board next year. Next year, the Board will need to elect four new members and a new chair person.

 - a. the above costs should be brought to the BoD to be included in the budget for:
 - b. By-law changes that George is working on (see above).
 - c. A committee was formed to investigate whether SAGE publications should take over the publication of the Missiology journal.

Adjournment: Phil Huber entertained a motion to adjourn the meeting at 5:25 p.m. The motion was seconded and unanimously adopted.

Report of the ASM Publisher

June 2013

This has been a lean year for ASM publications, but we are still in a transition mode as we get used to working with SAGE taking over the publishing of our journal *Missiology*. We have had some changes in the various committees and probably need to make more changes this year. The three areas of scholarly endeavor that come under the ASM Board of Publications and report to the Publisher are *Missiology*, the ASM Series published by Orbis Books, and the ASM Scholarly Monograph series published by Wipf and Stock that publishes recent doctoral dissertations. Each of these areas will bring a separate full report to the Board of Publications, but I want to comment briefly on these three areas of our ASM publishing efforts.

MISSIOLOGY. Our publishing of *Missiology* was handed over to SAGE who produced their first journal with the January issue, but not without a glitch. They left out the book reviews. The main concern that we will want to discuss is the rapid decline in subscriptions. According to our data base we had 715 subscriptions last year and it is now down to 458. All missiological journals are having trouble keeping the number of their subscriptions from declining. Rich Starcher, our editor will lead us in a discussion about possibly lowering the annual price for members.

ASM Series. The past year there were no books published in the ASM Series, but two books are under consideration. The main discussion we will need to have at the Board of Publication is recruiting members for the committee, and our relationship with Orbis Books.

ASM Scholarly Monographs. The leadership of the Scholarly Monographs editorial committee shifted from Mike Rynkiewich to James Krabill this year. The series had a banner year in 2012 publishing six monographs, numbers 11-16. This series is in good shape and our relationship with Wipf and Stock has gone very well. The monographs have a high quality of printing and presentation.

It is becoming clearer that we have work to do to keep up the volume and quality of our ASM publications. Perhaps we need to encourage our membership to begin considering ASM as their first choice of publishing their books in the ASM Series and their articles in *Missiology*.

Editor's Report – Richard L. Starcher
June 13, 2012

The year 2012 was a busy transitional year for *Missiology* as the journal moved its production to SAGE Publications. The transition was not without glitches (e.g., the omission of book reviews in the January 2013 issue) but, overall, has been remarkably smooth. The work of transition no doubt will continue through 2013, our first year being published by SAGE. The staff at SAGE (particularly Caroline Porter, James Tattle, and Jophcy Kumar) has been helpful and easy to work with.

I would be remiss to omit thanks to my editorial team: Eloise Menses, Colleen Mallon, Jay Moon, Jehu Hanicles, Bill Gregory, and David Fenrick. They have faithfully contributed to the quality of our journal.

The move to SAGE has resulted in parting ways with typesetter John Eagleson and Evangel Press, which handed printing and distribution. The move also contributed indirectly to the departure of Andi Greene, our editorial assistant, who was hired primarily for her copy-editing skills. Patti Colombo has assumed her remaining duties. SAGE Publications has retained the services of Jean Warren, our advertising manager.

The State of the New Missiology Office

The transition, coupled with an unusually heavy workload at Biola, severely taxed my capacity to keep pace with the demands of *Missiology*, particularly since the fall of 2012. Some authors undoubtedly were not served in a manner as timely as we would have wished. Otherwise, the editorial process (especially since the move to SAGE) has gone quite smoothly. SAGE's Online First feature now allows electronic publication of articles in advance of their appearance in print. Hence, the long print publication queue is less irksome to authors than in the past.

Discussion Item

One point of discussion I'd like to raise concerns subscription rates for members. SAGE charges non-members \$33/year for an individual subscription. We include a subscription in the \$40 membership dues. Previously, \$30 of that \$40 was applied to members' *Missiology* subscription. Presently, SAGE charges members only about \$15 for their subscription. Hence, ASM now can apply \$25 rather than \$10 of a member's due to general operations. We might want to consider reducing dues to \$30 or \$35.

ASM Series Committee¹

Report to ASM Board of Publications

20 June 2013

During the period since the Publications Board last met, there have been no books published in the Series. This has been an exceptionally long fallow period, something made more serious by the absence of proposals that will see books published before June 2014 when the ASM meets again.

It should be remembered, though, that in Spring 2012, before the last meeting, Stanley Skreslet's *Comprehending Mission* was published as well as the volume of essays edited by Stephen Bevans, *Mission & Culture: The Louis Luzbetak Lectures*. Both are extremely valuable, high quality books

In addition, Robert Hurteau's biography of John J. Considine, MM, who was the principle missiologist of the Maryknoll Society, would have been in the series except for an accident. It (*A Worldwide Heart: The Life of Maryknoll Father John J. Considine*, Orbis 2013) was tentatively approved by the committee five years ago. The book was delayed and, unfortunately, when Bill Burrows stopped working with Bob a year before it was published, he forgot to remind Orbis that it was to be in the Series.

Four books under Consideration

- The first is a completed manuscript by Harvey Kwiyani, a Malawian by birth, who has a PhD from Luther Seminary. It is entitled *Blessed Reflex: A Missiological and Theological Perspective on African Missions to the West*. It is a book on African Protestant pastors/missionaries in the U.S. and U.K. Harvey has worked in both Europe (U.K., Germany, Switzerland, and Austria) for seven years. For six years now Harvey has been involved in the missional church conversation in the United States, where he focuses his attention on issues of missional leadership. *Blessed Reflex* is based on his dissertation. Bill met with Harvey in October in St Paul and was very impressed with the work. Bill suggested that a chapter or two on the role of Catholic priests and religious would make it much more interesting and saleable. Orbis made the same suggestion.
- The second is by Jonathan Tan on Asian missionaries, both in Asia and elsewhere. We have expressed strong interest in the project (subject to approval of the finished manuscript). Jonathan (who is Malay Chinese by birth) has moved from Xavier University in Cincinnati to Sydney, where he is professor at the Australian Catholic University. He has written a fine, award-winning book on Asian-American theology, a masterly dissertation on the missiology of the Federation of Asian [Catholic] Bishops Conference's, and several lengthy, profoundly researched articles on fundamental themes in mission and underlying Asian motifs. We are, then, confident he will deliver a good

book, though his move to Australia has thrown him off his schedule. Orbis has indicated it will do the book if the quality is as high as is expected.

- Ennio Mantovani, SVD, “The Dema and the Christ,” an indepth examination of Melanesian culture in its two major transitions (1) from hunter-gatherer to gardener; and (2) from gardener to Christianity. Asking and suggesting answers to the question: Exactly how did traditional religion affect the response to Christianity and what are the basic issues in Melanesian Christian identity?
- R Daniel Shaw & Bill Burrows, editors, “Socio-Religious Dynamics of Ritual and Ceremony: Toward a Realistic Christian Theological Viewpoint. Working from, among other things, Paul Hiebert’s contention that Westerners have excluded traditional rituals and beliefs from serious theological consideration, Shaw and Burrows gather grassroots views on this issue.

We decided against three manuscripts during the year. Following our general policy, we do not reveal the authors or the titles, viewing that as confidential information.

Issues for discussion and guidance

1. The composition of the Series Committee going forward
2. Continuing or not the Series placement at Orbis.
3. The small number of proposals and manuscripts we are receiving.

ASM SCHOLARLY MONOGRAPH SERIES

Annual Report (June 2013)

1. **Wipf and Stock.** The ASM Scholarly Monograph committee continues its good relationship with Wipf and Stock publishers and is pleased to continue the series with the imprint of Pickwick Publications.

2. **Committee discernment.** The mandate to the committee is to read and evaluate dissertations that would be useful to the study of mission if they were made available in a timely manner. The committee has been working with few guidelines, but among them are:

- give priority to PhD dissertations defended within the last five years,
- consider the missiological import of the dissertations,
- attempt to keep a balance of manuscripts accepted (men/women, continental distribution, institutional representation, themes developed, etc.),
- evaluate whether or not they should be published by ASM,
- where needed, provide suggestions to the author.

3. **Website update.** I have worked with Dorothy Carroll to update the Scholarly Monograph website (see second page of this report). Included have been:

- New chair data and contact information
- Full listing of all current committee members
- Full listing of all sixteen Wipf and Stock publications (2007-2012), including six new titles added to the list in 2012
- Full listing of seven earlier publications appearing in the “ASM Dissertation Series” (1997-2005)

4. **Current status of manuscripts (June 2012-June 2013):**

- The committee read and decided not to publish several dissertations.
- Two theses have been approved and are currently in the hands of Wipf and Stock.
- Three texts are being reviewed by committee members (three approval votes are required before recommendation for publication).
- Two manuscripts just arrived and are being assessed for possible review.

5. **Issues and questions for discussion and direction:**

- Committee members work hard on volunteer time to review manuscripts. The flow of texts into our hands has continued in 2012-2013 and will likely grow as the word gets out about the Monograph series as a possibility for publication.
- Several of our committee members are new to the team and we hope to establish this year a more intentional pattern of cycling on and off of the committee to provide a healthy balance of newer and older members.

In its initial years the series was co-published with the University Press of America, and from 2006 onward it is being co-published with [Wipf & Stock Publishers](#).

The ASM Scholarly Monograph Series makes more widely available quality scholarly work relating to the area of world mission. The Series welcomes submissions of doctoral dissertations completed in the last five years at universities and theological institutions in North America and around the world. Other similar scholarly monographs are also welcome. The manuscripts must be in English.

Authors wishing their dissertations or monographs to be considered for the Series must first submit an abstract, table of contents, and a letter explaining the relevance and importance of the study to the ASM Scholarly Monograph Series Editorial Committee Chair, [James Krabill](#). If the topic is deemed of interest and appropriate, the Chair will request three hard (i.e., printed, not electronic) copies of the dissertation, one to each member of the Committee. These will not be returned. Members of the Series Committee, who may request assistance from expert readers on specialized topics, judge the dissertations. Every effort will be made to make a decision on the publication on the dissertation within three months.
